Adam then worked for four years in a financial planning and analytics role at Hireup, an NDIS online platform that enables people with a disability to find the right support workers for them. He is a passionate disability advocate and would like to help improve the outcomes of people in the Fragile X community and the effectiveness of the NDIS. Adam was first appointed to the Board at the AGM on 27 October 2019 and serves as Treasurer.

Prior to moving into industry Karen worked as a veterinarian in small animal practices both in the UK and in Australia. Karen has the Fragile X premutation. Belinda has an online skincare business and is busy with therapy/intervention appointments for her boys. Belinda is extremely passionate about raising awareness of Fragile X syndrome and keen to support the Fragile X community. She has been involved with FXAA since her boys' diagnoses in early 2020. Belinda has fundraised for FXAA, organising a large Trivia Night event, and has represented FXAA at a range of disability expos and the Sydney City2Surf fundraising evet. Belinda was appointed to the Board at the AGM on 21 November 2021.



Mandy Barker

Mandy is involved in social media marketing and business development, specialising in the disability and aged sectors. Mandy lives in Brisbane. Her son was diagnosed with Fragile X syndrome at age 8. While he had previously been diagnosed with Autism and received appropriate supports, the diagnosis had not fully explained his developmental delays. Shortly after this, her older daughter was also found to have FXS. Mandy is a keen advocate for raising awareness of FX and intellectual disability in the broader community; for earlier diagnosis; genetic screening; and inclusion in everyday life. Appointed to the Board at the AGM on 21 November 2021, Mandy has been involved with FXAA since 2017. She has proposed fundraising initiatives, represented FXAA at medical and disability conferences, and designed FX Awareness cards.
